CALL TO ORDER: Commissioner Troy called the meeting to order at 10:02 a.m., August 7, 2014.

ROLL CALL: Upon the roll being called all were present.

OPEN TO THE PUBLIC:

Commissioner Troy asked if anyone in the audience wished to address the Board.

Mr. Bruce Landeg, City of Mentor Councilman, stated that he was a stakeholder on a study supported by the Port Authority that took place regarding the Lost Nation Airport and he learned the airport's consultant stated that the airport was not an economic magnet. He called for a purpose and needs statement and stated that showing duplication of service has not been answered. He also requested additional public hearings before voting on the resolution. Mr. Landeg asked for clarification about where the local share of the cost will come from, the grant, the safety under the County for the airport and surrounding area, and he asked about building a tower on the

Mr. Bernie Gantzer of Mentor stated that there is a need for businesses and jobs in Lake County in order to keep the young people here. He recommended that this issue be placed on the ballot for the people to decide. Commissioner Troy thanked the public for their comments. He explained what is normally placed in front of the voters is the financing of public improvements or bond issues. There has been a lot of due diligence that has taken place and it has been an eight-year process. A major concern was that the airport cannot be drawing on general tax dollars. Through many studies and discussions it was concluded that the operation of the airport will be self-sustaining. We have a republican form of government, small "r", and the people elected the Commissioners to make these types of decisions.

Commissioner Aufuldish replied that in his opinion, the voters spoke when they elected the Commissioners to represent them. He has been elected five times to office and has done his due diligence and does the best of his ability. He attends 50 meetings a year and passes an average of 20 pieces of legislation at each meeting. This is a key vote for this County and it is a major step for economic development for this County.

Commissioner Moran stated that she met with Mr. Landeg and the FAA and they were all in favor of what is happening and they noted that we are on the right track. She is looking forward to improvements at the airport because once it is gone, it is gone. A business district is what will be fed off of this project. This will be a selfsustaining project.

Commissioner Troy stated that this has been under discussion for eight years. After the creation of the Port Authority, they were asked to look into the airport. They received outside funding for independent studies and they were charged with making the best decision for the economic health of the County. The Port Authority exercised due diligence. The City of Willoughby has passed a resolution unanimously for the airport transfer. This venture will not require any subsidies and Willoughby actually made a small profit. The issue with the airport is that since 1996, there has been uncertainty surrounding the airport, and, as a result, few investments have been made. If approved by the FAA, the airport will continue to exist under new management and master planning will take place that will improve the look of the property. There will not be any expansion of runways. Planning ahead will ensure that Lake County remains economically viable, encourage investment and re-investment by the businesses, keep people working and keep tax dollars being paid. This decision is recommended by the Port Authority and should the resolution pass today, the Commissioners salute them for their hard work.

Commissioner Aufuldish stated when something of this magnitude is done, rumors start to fly. Mayor Anderson of Willoughby is in attendance and they have all seen the finances of the airport and they have not lost money. The airport will be a great economic development tool for Lake County and he thanked the mayor for his patience.

Commissioner Moran stated that a great deal of research and development is being done at the airport and this will be good for the County.

County Administrator, Mr. Jason Boyd, stated between 2005-2007 Lakeland put forth an economic development strategy that indicated some catalytic projects throughout the County and the Lost Nation Airport was one of those projects along with lakefront development plan and industrial park development and redevelopment. This will provide a predictable, sustainable future for economic development for the County.

Commissioner Troy stated that Mr. Tim Miller, Stormwater Management Director, has been working with the communities to begin the process of incorporating them into the program. Willoughby and Eastlake are important to have as partners for the Chagrin River watershed.

Commissioner Troy reported that this resolution allows the Dog Shelter to comply with state law. The law was changed to allow for lifetime or three-year dog licenses. There was a grey area in terms of penalties for those who got the licenses late.

Mr. Rodney Shelton, Animal Control Officer, explained that this resolution allows them to sell a three-year license outside of January 1 to December 31. It allows for late penalties and after July 1 it offers a pro-rated fee at 83% outside that period. This addresses the grey area. To date, the Dog Shelter has sold 650 three-year registrations

and 63 permanent registrations. They anticipate that these numbers will increase.

Commissioner Troy stated that the Dog Shelter's operational funding comes out of license fees and not the general fund.

Commissioner Aufuldish reported that he has attended every court of honor for Boy Scout Troop 5 and is sad to report that there are not enough boys in the troop to renew their charter so this will be the last Eagle Scout from Troop 5.

DEPARTMENTAL REPORTS:

<u>UTILITIES</u> - Mr. Rick Martin, Department of Utilities Director, explained the importance of source water $protection\ relating\ to\ algae\ blooms\ because\ of\ the\ recent\ events\ that\ occurred\ recently\ in\ Toledo\ to\ their\ water.$ He stated that most algae blooms are caused by agricultural run-off. All water plants follow a strategic plan recommended by the EPA called the Public Water System Harmful Algae Bloom Response Strategy. The plan involves three steps: 1. Observation and testing, 2. Screening, 3. Cyanotoxin monitoring. The County has never had to go past step 1. He explained that NASA flies a plane over Lake Erie every week that takes pictures and gives a forecast of when a bloom will appear.

Mr. Martin explained that an algae bloom is different than a dead zone, which sometimes happens in September. A dead zone occurs when the lake turns over and the algae that has died and settled at the bottom of the lake is churned up and depletes the oxygen in the lake, which causes fish die or leave the area. This is constantly being

Commissioner Troy stated that citizens appreciate how conscientious the Utilities Department is at the plants. The Aquarius Plant serves the west end of the County and the Bacon Road Plant serves the east end of the County. A lot of work has been done upgrading the plants. He was able to sponsor and get passed, over Proctor and Gamble's opposition, the Detergent Phosphorus bill in the legislature to be sure no detergents containing phosphorus are sold in the 35 counties in the Lake Erie watershed. Also, recent storms cause untreated water to get out into the lakes. He thinks it may be time for a Lake Erie summit. Failing household septic systems do not help. The lake is Ohio's greatest asset and some tough decisions have to be made by the legislature. He stated that he will be attending the County Municipal Leaders Conference hosted by the Ohio Sea Grant Program meeting on August 20 to see what we can do to address the issue because this is not just about our drinking water but the economic health of the County and State.

Commissioner Aufuldish thanked the Utilities Department for being pro-active.

<u>NEW BUSINESS</u>: -Commissioner Troy asked about a Facility Planning Area Boundary Request Change for Heatherstone and Mr. Al Saari, Sanitary Engineer, replied that is to clean up the boundary lines and making what exists out there official.

Commissioner Aufuldish thanked Ms. Donna Tyson for creating all the collages of municipalities in Lake County for the Commissioners' Chambers.

PUBLIC COMMENT: Commissioner Troy asked if anyone in the audience wished to address the Board?

Mr. Jim Brown, owner of Classic Auto Group, stated that he has been in business in the County for 35 years and he stated that it is a great County to work with and he appreciated the cooperation between entities. This transfer of the airport is the biggest economic opportunity in the County. He stated it is important to make the County an exciting place to be. It is an attitude. Lake County can do a lot about jobs and this will help. Nothing has been done to improve the airport because of its uncertain future. Now there are plans to build hangars, fix cracked runways and taxiways, and add a restaurant and weather reporting station. This is an exciting venture and it will be a big success. There are people who want their offices where their plane is located.

Ms. Becky Lynch, 8040 King Memorial Drive in Mentor, clarified that Mentor does not have a mayor, but a city manager and also clarified in the Constitution Article 4, Section 4, reads "The United States shall guarantee to every state in this union a Republican form of government, and shall protect each of them against invasion," and it is a capital "R."

Commissioner Troy stated the constitution was written in 1787 and the Republican party was not formed until 1856

She stated that all three Commissioners indicated that the airport will be self-sustaining and if any subsidies are required this will be re-visited. She stated that grant money is not free money. She stated that she is happy to see private industry stepping up because she loves airports and it will be an asset to the County. She stated that she was there when the study was done and stated that work on this airport was done before the Port Authority was involved. As for public meetings, she stated that she has requested in writing public-friendly meeting times.

Willoughby Mayor Dave Anderson stated that this is a good decision made possible by a few good decisions made by the Board of Commissioners in the past like establishing the Port Authority and directing some casino revenue through the Port Authority for economic development. That made possible the decision made here today. This is great leadership.

Commissioner Troy stated that casino money, which the County used to supplement some of the downturn in investment earnings and lower property values, but a substantial portion was committed to economic development activities, which helps all communities in the county. Lake County local governments are receiving the best deal in the State of Ohio in terms of distribution of the Local Government Fund, better than any other county in the State.

Mr. Bruce Landeg congratulated everyone on the airport transfer pending FAA approval and he asked what the FAA grant is for and what is the local share? He was glad to hear that the airport will be self-sustaining. He also asked about the safety issues, particularly the tower.

Commissioner Troy stated with the technology today a tower is not needed.

Ms. Patty Fulop, consultant for the Port Authority on FAA issues, stated that they have not applied for the grant at this time. In order for the airport to move forward, one of the FAA regulations is to accept terms and conditions, if you do accept a grant.

Commissioner Troy stated that it is has been his understanding that FAA grants are 90/10 with the local match being 10%. After discussions and studies, it was determined that revenues generated by economic development would generate the money necessary to meet the 10% match. The desired goal is to not use Port Authority or casino money but internal airport operation dollars for the local share.

Commissioner Troy stated the next regular Commissioners Meeting will be held on Tuesday, August 12, 2014 at 2:00 p.m.
