Mr. Dwayne Bailey, Village Administrator, thanked Mr. Rothlisberger and Mr. Martin for their patience and support in reviewing the contract. It is important to secure the water supply for the future at an affordable rate and it will improve both sides of the system. The agreement will provide a better supply of water and open up the opportunity for future expansion.

Commissioner Troy asked if this agreement brings regionalization of the system closer to a reality?

<u>UTILITIES</u> - Mr. Matt Armand, Public Service Coordinator for the Department of Utilities, reported on the Department's commitment and dedication to customer service. They created a survey for customers that has been very successful and recently developed a customer service model and assessment. The new program is to record phone calls and randomly review them because those answering the phones are the first level of dialog with the public. This is another element of the Department for its on-going commitment to customer service and he will give further updates about this new program in the future.

Commissioner Troy stated that the Commissioners are aware of Mr. Armand's role in enhancing customer service and it appears to be working since the Commissioners are receiving fewer calls.

Commissioner Troy reported that the next special collections event is September 26, 2015 for Household

<u>NEW BUSINESS</u>: - Commissioner Troy stated that the OPWC District 7 held its re-organization meeting yesterday. Lake County is represented by Commissioners Troy and Malecek. Mentor City Manager Ken Filipiak and Commissioner Troy are on the Executive Board. They approved round 30 projects and requested that the final applications be submitted. Some of the projects will take place in Grand River, Fairport, Willoughby, Painesville, and Painesville Township.

PUBLIC COMMENT:

Mr. John Muzik, 45 Coventry Drive in Painesville Township, requested that the Commissioners rescind the resolution regarding the matricula consular identification card. He cited a September 25, 2010 News-Herald article that speaks to the perception of the card by the public. He also referred to Article 19 published in 2003 that read that there was no U.S. data base to verify this card. Former Lake County Chief Deputy William Crosier response and FBI testimony are also great sources of information and he encouraged the Commissioners to further investigate the card. Mr. Muzik thought it was upported adopt the resolution in the first place in the first place. further investigate the card. Mr. Muzik thought it was wrong to adopt the resolution in the first place because it deals with the federal government and the County should stay out of federal government issues.

Mr. Muzik asked that the Commissioners remember that five people who crashed planes into buildings on 911

August 27, 2015

and they were in the country illegally.

Commissioner Troy stated that he will not forget 911 because the wife of a college classmate of his was on the plane that crashed into the Pentagon.

Ms. Arzella Melnyk, 10506 Hobart Road in Kirtland, stated that she copied a portion of the Consulate of Mexico in Detroit report for the Commissioners. The Commissioners have said that the card is to identify that people are from the Republic of Mexico. One of the pages indicates that the card is commonly used to identify oneself to law enforcement and apply for public utilities The report also stated that 178 banks accept the card as does 33 states and people in 12 states can obtain a driver's license with the matricula card. This report was dated 2004. She was told that this was a ceremonial resolution and it was passed in 2005 and the report came out in 2004. She asked the Commissioners to consider rescinding the resolution.
