There was still competitive bidding.

## RESOLUTION PROCLAIMING SEPTEMBER 2015 CHILDHOOD CANCER AWARENESS MONTH IN LAKE COUNTY (20150903\F01)(C-126)

On a motion of Commissioner Moran, seconded by Commissioner Troy.

Commissioner Moran read the resolution in its entirety and stated that only 4% of funding raised is used for childhood cancer research and it is coming more prolific. She recently attended two fundraisers for children battling cancer and stated that this is an extremely important issue. Their mother's requested this resolution. Commissioner Troy stated that this is an issue that should be given the utmost attention.

### **DEPARTMENTAL REPORTS:**

UTILITIES - Mr. Matt Armand, Public Service Coordinator for the Department of Utilities, reported on the status of credit card usage and stated that over 1,000 customers made payments using the new credit card method. This payment option was extremely beneficial during the certification process and every day the usage increases. This is yet another avenue to make payments and the public seems appreciative and welcomes the new

Mr. Rick Martin, Executive Director of the Department of Utilities, reported on the Waterline Repair Program and explained that there are typically about 260 water main breaks annually in the drinking water systems. Water breaks continue to be high this year as it was last year with 315 main breaks. When a break occurs it can damage treelawns and roadways. A crew is sent out to make the small repairs. Currently there are two areas that require more repairs; Downtown Willoughby which will cost about \$50,000, and an area in Wickliffe which will cost about \$20,000 to \$30,000. They try to employ local entities for the repair work. Commissioner Troy asked why there are breaks in the summer?

Mr. Martin replied that it is because of the age of the lines. Many of these lines are 83 year old pipe that Mr. Rothlisberger, Sanitary Engineer, has looked into replacing. The life of a water line is usually designed for 50 years. He indicated there was a period in the 1960's when the pipes manufactured were substandard and they are not getting even 50 years out of them.

Commissioner Troy stated that Youngstown areas State Senator, Joe Schiavoni, introduced a \$1 billion water and sewer bond issue proposal that would generate \$100 million a year for 10 years. There is bi-partisan cosponsorship in recognition of the deterioration of the underground infrastructure throughout the State.

Commissioner Moran stated that she has heard nothing but good things about the new payment options and asked if there was a fee involved with credit card payments?

Mr. Armand replied that there is a 2.5% standard convenience fee.

Commissioner Troy stated that he and Commissioner Moran attended Ohio Sea Grant's 8<sup>th</sup> Annual Lake Erie Day for Coastal County Commissioners and stated that he has never seen the water look so bad with algae. They are attributing this problem to agricultural runoff from the Maumee River basin and researching solutions.

Ms. Lynch stated that she sent letters to both Commissioners Moran and Malecek about this fundraiser and she asked if the letter was received?

Commissioner Moran replied that the letter was received and she is working on a response.

Commissioner Moran replied that she did not know how much money was raised but she would find out. She and Commissioner Malecek were announcers and she did not solicit any money herself. Commissioner Moran did raise money a few years ago.

Commissioner Moran reported that on September 6, 2015, at 11:00 a.m. there will be a 9/11 Remembrance Ceremony at Eastlake City Hall.

Commissioner Troy stated that the next regular Commissioners Meeting will be held on Thursday, September 10, 2015 at 10:00 a.m.
