CALL TO ORDER: Commissioner Troy called the meeting to order at 2:05 p.m., September 15, 2015.

#### 11. RESOLUTION PROCLAIMING SEPTEMBER 22, 2015 DEMOCRACY DAY IN LAKE COUNTY, OHIO(20150915\F01)(C-107)

On a motion of Commissioner Moran, seconded by Commissioner Malecek.

Commissioner Malecek explained at the next Commissioners Meeting on September 22, 2015 at 6:30 p.m. a public hearing will take place for Democracy Day. The reason this date was chosen for the evening meeting was because Probate Court Judge Mark Bartolotta, Clerk of Courts Maureen Kelly and Recorder Ann Radcliffe are conducting a "Good Deeds" program that evening and the building will be open. The City of Mentor voters enacted a Democracy Day resolution a year ago with a 75% vote. This is an opportunity for residents to come forth and discuss the court case, Citizens United v. the Federal Elections Commission, which allows unlimited corporate spending to influence campaign, elections, lawmaking and public policy decisions, or any other topics. Commissioner Troy stated that this is a special resolution. The only ways a court decision can be changed is for the U.S. Supreme Court to revisit the decision, which rarely happens or by a Constitutional Amendment that requires 2/3rds vote by the U.S. House and Senate and then ratified by 38 of the 50 states. This is nothing the Commissioners can act upon or adjust, but it allows citizens to step forward to make comments.

### **DEPARTMENTAL REPORTS:**

<u>UTILITIES</u> - Mr. Matt Armand, Public Service Coordinator for the Department of Utilities, reported that two inches of rain fell over the weekend and crews were out. He was happy to report there were no recorded customer complaints. The crews were prepared and did an excellent job.

Commissioner Troy asked if there were any reports of flooding basements and Mr. Armand replied there were

Commissioner Troy asked if there have been any algae issues at the water intakes?

Mr. Rick Martin, Executive Director of the Department of Utilities, replied there were very low levels and after the tests were run on Monday the levels were decreasing. As soon as any algae is detected they began using activated carbon and they continue to monitor the situation.

Commissioner Moran commended the Utilities Department for doing a wonderful job with the Open House at the Madison Wastewater Treatment Plant over the weekend. It was well-attended despite the weather

Commissioner Troy stated that the work that the employees at the plants do is important to the health of Lake Erie, and the upgrades and expansions occurring at the plants help them to do a better job.

NEW BUSINESS: - Commissioner Troy reported that the Commissioners received a letter from Secretary of State Husted thanking the Commissioners for their support of online voter registration. On June 24, 2015 the Ohio Senate passed a bill that would create an online registration system. It was supported by Senators of both parties by a 31 to1 margin. The bill now moves to the Ohio House. This will save the County some money.

Ms. Arzella Melnyk, 10506 Hobart Road in Kirtland, stated that she made a copy of an article for the Commissioners that specifically states that border patrol found that special interest aliens smuggled across the border had these cards in their possession. She stated that the card can be fraudulent and asked the Commissioners to rescind the resolution endorsing the matricula consular identification card.

Commissioner Troy stated that Lake County does not issue or accept these cards as legitimate identification for

any County purposes.

Mr. John Murphy, 127 Chestnut Street in Painesville, reported that Mr. John Muzik was not in attendance at the meeting because he had hip surgery successfully and he his home.

Ms. Becky Lynch, 8040 King Memorial Drive in Mentor, asked for a copy of the Democracy Day resolution. She stated that this is a worthless, unactionable, affectless resolution.

Ms. Lynch asked if Democracy Day was passed today?

Commissioner Troy replied that the Commissioners proclaimed September 22, 2015 would be Democracy Day. This special resolution was reviewed by the Prosecutor's Office and the City of Mentor overwhelmingly voted to hold Democracy Day annually and affords people the opportunity to speak on this particular issue.

Ms. Lynch stated that this is not being brought up by Lake County residents but by a national group called MTA. She stated if this resolution was not going to affect anything then why even bother.

Commissioner Malecek stated that this will provide people the opportunity and venue to voice their opinions.

September 15, 2015

Ms. Lynch took exception to the statement because people can speak at any time during any public meeting. Commissioner Troy stated that this gives people an opportunity to speak. One might in fact say that the Citizens United ruling does to some degree negate the right of people to have their opinions heard because of huge money coming into national elections?

Commissioner Troy stated that the next regular Commissioners Meeting will be held at 6:30 p.m. on Tuesday, September 22, 2015.
