CALL TO ORDER: Commissioner Troy called the meeting to order at 2:05 p.m., December 29, 2015.

OPEN TO THE PUBLIC: Commissioner Troy asked if anyone in the audience wished to address the Board. Deanna Rowe, owner of Homestead House Bed and Breakfast, Willoughby. Received a letter from County Administrator Boyd regarding the proposed bed tax increase. She referred to an article in the Tribune stating that the increase would not be paid by Lake County residents and she does not feel this is true. She explained that she has been in business for 10 years and approximately fifty-percent of her visitors are from outside of the United States, forty-percent are people coming to visit family members and ten-percent she considers 'true visitors'. Ms. Rowe feels this increase would be paid by the small businesses in Lake County. She asked that the Commissioners consider the small business owners and the impact the increase would have on them. She is hoping for some positive changes to the Lake County Visitors Bureau in the coming year or two. Commissioner Troy explained the Lake County, Ohio Port and Economic Development Authority went to the legislature for a funding stream to generate funds for lakefront improvements and this was the recommendation. Commissioner Troy appreciates Ms. Rowe's input on the bed tax increase and the Commissioners will take her opinion into consideration. Commissioner Troy explained this is not a general tax used to fund day to day operations but a tax specifically earmarked for lakefront improvements. Commissioner Troy agreed with Ms. Rowe regarding the Visitors Bureau and congratulated her on the success of the Homestead House Bed and Breakfast.

Leroy Township Trustee Chuck Klco was present and added that they are in full support of this project and will also pass a resolution of support. Mr Klco explained this property is near the Blair Road Bridge and, upon the passing of the property owner, was donated to the Cleveland Museum of Natural History.
