CALL TO ORDER: Commissioner Hamercheck called the Meeting to order at 10:05 a.m. Thursday, February 3, 2022.

ROLL CALL: Upon roll being called, Commissioners: Young, Plecnik and Hamercheck were present.

APPROVAL OF MINUTES:

Upon a motion by Commissioner Young, seconded by Commissioner Plecnik, the minutes of the Regular Meeting of January 20, 2022 were approved with the vote as follows: "AYES": Commissioners: Plecnik, Young and Hamercheck "NAYS": None.

<u>OPEN TO THE PUBLIC</u>: Commissioner Hamercheck asked if anyone in the audience wished to address the Board. Mr. Brian Massie of 8196 Rainbow Drive, Painesville, discussed with the Board political parties and the number of signatures required to file petitions. Assistant Prosecutor, Mr. Michael DeLeone, explained that the Board of Commissioners have no jurisdiction over the Board of Elections.
