CALL TO ORDER: Commissioner Hamercheck called the Meeting to order at 10:07 a.m. Thursday, February 10, 2022

5. RESOLUTION AUTHORIZING EXECUTION OF AN AGREEMENT BETWEEN THE LAKE COUNTY BOARD OF COMMISSIONERS AND LIFELINE, INC. AND FAIR HOUSING RESOURCE CENTER, INC. FOR THE IMPLEMENTATION OF EMERGENCY RENTAL ASSISTANCE PROGRAM- 2 (ERAP-2) FUNDS(20220210\C01)(C-34 B)

On a motion by Commissioner Plecnik, seconded by Commissioner Young. Ms. Marian Norman, Program Manager, explained that the Emergency Rental Assistance Program 2 (ERAP-2) has received \$2,174,427.96 in funding as a part of the American Rescue Plan Act of 2021. This figure is part of a total potential allocation of \$5,436,069.70. ERAP 2 has a similar purpose to ERAP 1 but also has some key differences. Two of those program differences include the time of performance extends to September 30, 2025 and that a household's hardship does not need to be related to COVID, only that it occurred during the COVID timeframe beginning March 2020. She further explained that this resolution approves the use of the same partner agencies used for ERAP 1, Lifeline Inc. and Fair Housing Resource Center, Inc. These partner agencies implementing ERAP 1 have reached the needed staff levels to perform intake and they can continue on with ERAP 2. She stated that their staff has been trained in application intake and processing of financial assistance. They will also continue to adhere to the US Treasury provided guidance and oversight of these grants. Some of the practices include the use of various means of applying in person and over the telephone. Currently they are not accepting applications online in an attempt to limit or eliminate fraud. <u>NEW BUSINESS</u>: - Commissioner Hamercheck stated that he recently attended the JEDI Committee of CCAO and one topic of discussion was legislation pertaining to delinquent and/or unpaid utilities bills and the possible creation of a grievance committee.

Sheriff Leonbruno reported that he has just returned from the National Sheriffs Association Winter Conference in Washington, DC. One of the major topics discussed in the meetings concerned the significant increase in drugs moving into the United States by the drug cartels across the southern border. Highways such Interstate 90 moving coast to coast are major thoroughfares. Thus, counties they traverse are major areas for meetings and distribution points. The Lake County Sheriff's Office has been working with other police agencies such as Willoughby, Mentor, and Willoughby Hills under federal grants such as Stone Garden to pay for increased investigations and targeted enforcement along the I-90 corridor to stop drugs and related crimes such as sex trafficking from being viable options in Lake County.

<u>PUBLIC COMMENT</u>: Commissioner Hamercheck asked if anyone in the audience wished to address the Board. Mr. John Muzik of 45 Coventry Drive in Painesville, continued the Sheriff's report regarding fraud, immigration and drug issues. Commissioner Hamercheck thanked Fair Housing for their swift action in dealing with the online fraud. Job and Family Services Director, Ms. Suzanne Casar, stated that her agency has several employees whose specific job is to investigate potential fraud.

County Recorder, Ms. Becky Lynch, thanked the Board for the special certificate and press release and stated that her success, along with her staff, is due to five years of diligence.

Lake Development Authority Executive Director, Mr. David Anderson, announced that an agreement was reached yesterday for leasing of the Weston building in Willoughby to a division of Lincoln Electric. At this time, he does not know the number of jobs it will bring to the City of Willoughby but stated he will keep the Board updated on this good news.

Adam Litke from the Health District stated that they have mailed out a Community Health Assessment and encouraged all Lake County residents to participate in answering the questionnaire. He stressed that this is a very important survey that will assist the Health District in addressing and targeting the needs of the County.
