**RESOLUTION APPROVING THE 2022 PERMANENT APPROPRIATION MEASURE FOR FUNDS

BE IT RESOLVED, by the Board of County Commissioners, in and for Lake County, Ohio, that to provide for the current expenses and other expenditures of said County, during the fiscal year ending December 31, 2022, and the following sums being the same are hereby set aside and appropriated for the several purposes for which expenditures are to be made during said fiscal year of 2022 and that this be a PERMANENT APPROPRIATION for the year 2022, pursuant to O.R.C. 5705.3 and the sums and categories appropriated to be as follows:
