On April 18, 2022 Commissioner Plecnik toured the Ohio Means Jobs (OMJ) Lake County Career Center as well as the Lake County Department of Job and Family Services (JFS). provide workforce services to employers and job seekers. Staff members are eager to determine and immediately address the needs of every customer entering the Career Center.

The OMJ Lake County Career Center is also an important resource for employers looking to fill vacant positions within their organization. According to Cory Vojak, Director of Workforce Development for the

As a recent example, the OMJ Center recently collaborated with the Lake County Department of Utilities on an event to promote career opportunities within LCDU that was attended by approximately 100 job seekers."

Commissioner Plecnik also received a tour of the Lake County Department of Job and Family Services (JFS) Building. The programs at JFS assist individuals and families with a variety of needs to restore, maintain or improve their capabilities for self-support and family life. Commission Plecnik met with Division Administrators to discuss Public Assistance Programs, Children & Adult Protective Services, Public Employment & Training Services and Child Support Enforcement Programs.

"I extend my sincere appreciation to Director Casar and her entire staff for the critical services they provide to Lake County families who often have nowhere else to turn. You cannot overstate the importance of the work that occurs in our JFS Department," said Commissioner John Plecnik.
