DEPARTMENTAL REPORTS:

<u>UTILITIES</u> – Sanitary Engineer, Mr. Randy Rothlisberger thanked Commissioner Young for his years of continued support of the Utilities Department.

<u>JOB AND FAMILY SERVICES</u> – Job and Family Services Director, Ms. Suzanne Casar, wished Commissioner Young best wishes and stated what a pleasure it has been to work with him.

<u>COUNTY ADMINISTRATOR</u> – Jason Boyd stated that Commissioner Young always answers the phone and states "It's a great day". On behalf of Mr. Boyd and his staff, he wished Commissioner Young many, many "great days" in his future.

FINANCE - none.

<u>CLERK</u> – Commissioners Clerk, Ms. Jennifer Bell, stated that the next Commissioners Meeting will be held on Thursday, May 5, 2022 at 10:00 a.m. Ms. Bell stated that it has been a pleasure working with Commissioner Young and wished him the best.

<u>LEGAL</u> – Assistant Prosecutor, Mr. David Hackman, thanked Commissioner Young for this service at both the State and County levels and wished him a happy, healthy retirement.

OLD BUSINESS: - none.

NEW BUSINESS: - Commissioner Hamercheck stated that the Board of Commissioners is committed to Lake County's economic growth and making Lake County a great place to raise a family and establish roots. He stated that this is a sentiment that he shares with Sheriff Leonbruno and the key to a safe community is strong law enforcement such as the unique COPS grant initiative that will continue over the next four years. Lake County also has a premiere communications system. Commissioner Hamercheck stated that Lake County is also a part of the Statewide Interoperability Executive Committee Board; Lake County is Zone 2 in the State. This is a strong commitment on the part of Lake County to not only the people of Lake County but also the region. We are also a part of the National Communications System. In order to have a safe community, we must have a strong Prosecutor's Office. Lake County enjoys a very strong and diligent Prosecutor's Office and judicial system. Commissioner Plecnik stated he would like to hear an update from the Sheriff on the COPS grant. With this grant, they were able to add 10 additional patrol officers on the roads. He was pleased to announce a very important investment in the Prosecutor's office to allow them to add additional attorneys and support staff. Commissioner Young acknowledged how hard the Sheriff's Department, Prosecutor's Office and Judges work to ensure the safety of Lake County. Sheriff Leonbruno addressed the COPS Grant, explaining that they were able to hire 10 additional men and women as deputy sheriffs to patrol and protect the townships. He thanked the Board for always supporting law enforcement. He explained that the Prosecutor's office must review very lengthy body cam video footage from not only the Sheriff's Department but all of the Lake County Police Departments. Commissioner Hamercheck gave a history of the COPS grants, stating that at one time there was a federal program. He explained the process that the Board, the Sheriff, Prosecutor's Office and the townships followed to come up with a fair agreement for the grant, adding that the County cannot obligate the township trustees to put into place the funding mechanisms but can offer a pathway for sustainability of this program. He pointed out that two of the townships are bigger than most cities in Lake County.

Lake County Prosecutor, Mr. Charles Coulson, was present and thanked Commissioner Young for his years of service to Lake County. He explained the drastic increase in their caseload and the many hours of work that goes into reviewing evidence, and hours and hours of video footage and cell tower records. He thanked the Board for recognizing the need for additional staffing.

Commissioner Hamercheck reviewed how the recent Statewide Interoperability Executive Committee Board provides guidance and strategic direction for public safety-first responders and their communications initiatives. He gave an update of the subjects discussed including software updates, radio upgrades and additional subscriber units to the MARCS system. He shared that the County was thanked at the meeting for our continued leadership, commitment and support of the statewide systems and the safety forces.

Commissioner Plecnik asked Mr. Dale Fellows to give an update on the upcoming primary. Mr. Fellows stated that the primary is May 3rd, 2022 and there is still time to vote absentee or go directly to the Board of Elections if you are not able to get to the polls that day. He explained that 59% of those requesting an absentee ballot have returned them and that they must be postmarked by May 2nd to be accepted.

Commissioners Clerk, Ms. Jennifer Bell, stated that Commissioners Hamercheck and Plecnik received a key to the City of Eastlake. Commissioner Plecnik shared his appreciation to the City of Eastlake. Ms. Bell also announced that Commissioner Plecnik was recently names Dean's Teacher at Cleveland-Marshall College of Law.
