CALL TO ORDER: Commissioner Hamercheck called the Meeting to order at 10:08 a.m. Thursday, May 12, 2022.

ROLL CALL: Upon roll being called, Commissioners: Hamercheck and Plecnik were present.

OPEN TO THE PUBLIC: Commissioner Hamercheck asked if anyone in the audience wished to address the Board. Mr. Brian Massie of 8196 Rainbow Drive in Painesville, inquired about the work hours required for elected officials. Assistant Prosecutor, Mr. David Hackman explained that for various elected officials, an absence from the office for 90 days deems the position vacant with the exception of the Treasurer and the Auditor which is only 30 days. Mr. Massie requested Mr. Hackman email him a written explanation for posting on his website.

Mr. John Muzik of 45 Coventry Drive in Painesville, asked the Commissioners to always please remember the financial difficulties of senior citizens.

On a motion by Commissioner Plecnik, seconded by Commissioner Hamercheck. Sheriff Leonbruno stated that his department has been working with the Board and the Prosecutor's office for this grant. He explained that the first application had been denied and through much hard work with the second application, they were able to secure the grant. He stressed the importance of body worn cameras for the officers in the field and how the footage can be critical evidence in some cases. Commissioner Plecnik commended Sheriff Leonbruno and his staff for their hard work to secure this grant. The facility will be able to handle three departments at a time and will be state of the art. #### **DEPARTMENTAL REPORTS:**

UTILITIES - none.

JOB AND FAMILY SERVICES – Director of Job and Family Services, Ms. Suzanne Casar, stated that this month is "Public Assistance Fraud Awareness Month" and explained that fraud is a statewide problem. Jobs and Family Services has a full-time staff dedicated to investigations of fraud. She also announced that it is "In Demand Jobs Week". Ms. Casar introduced Mr. Matt Myers from the Ohio Department of Jobs and Family Services adding that Mr. Myers' office is within Lake County Jobs and Family Services. Mr. Myers thanked the Board for the opportunity to speak and explained that In Demand Jobs Week is designed to promote Ohio's most in-demand and fast-growing industries through hiring, education and training events. Commissioner Hamercheck thanked Mr. Myers for his enthusiasm and energy and expressed his appreciation for his hard work. Commissioner Plecnik also thanked Mr. Myers for the work that he does.

<u>COUNTY ADMINISTRATOR</u> – Commissioner Hamercheck stated that Mr. Boyd continues to represent Lake County in Federal Court for the ongoing opioid trial.

FINANCE - none.

<u>CLERK</u> – Commissioners Clerk, Ms. Jennifer Bell, stated that the next Commissioners Meeting will be held on Thursday, May 19, 2022 at 10:00 a.m.

LEGAL - none.

OLD BUSINESS: - none.

<u>NEW BUSINESS</u>: - Commissioner Plecnik announced that earlier today, the Board had the privilege of rededicating the Wall of Service of former and current Commissioners by hosting a ribbon cutting. He stated that former Commissioners Sines, Malecek, Moran, Fellows, Young and Cirino (now Senator) were present.

<u>PUBLIC COMMENT</u>: Commissioner Hamercheck asked if anyone in the audience wished to address the Board. Mr. John Muzik of 45 Coventry Drive in Painesville, stated that he is in full support of a new jail and stressed the importance of law enforcement having the training and tools they need to protect the citizens of Lake County. He stated that he noticed scaffolding on the roof of the jail and asked what was being done. Commissioner Hamercheck stated that it is part of continued maintenance to the jail.

Mrs. Pokelsek of 6015 Cedarwood in Mentor on the Lake, spoke of a recently released movie titled "2000 Mules" and expressed her concerns regarding voter fraud. She stated how watching this movie started her thinking about voter fraud in Lake County and has her unbelievably concerned. Mrs. Pokelsek asked for the return of paper ballots and for a forensic audit of the recent Lake County primary election. Commissioner Plecnik stated that he will watch the movie and explained that Lake County has three cameras pointed directly at the outside ballot drop-off boxes; one of which records the drivers face. He explained that there is no internet connection to the computers that count the votes and that it is basically a calculating computer. Commissioner Plecnik also explained that the new voting machines print out a paper ballot of the choices the voter made for their review and verification before casting their vote into the paper ballot machine. This extra step is for the voter to verify they have pushed the right choice and that everything on the paper ballot matches their choice. He explained that the Lake County Board of Elections is required and does perform a random pull of votes to verify all information.

Commissioner Hamercheck stated that he is not familiar with the movie either. He explained to Mrs. Pokelsek that the electronic pollbook verifies the signature of the voter and only shows eligible voters in the system. He went on to explain that the second machine is a hybrid of sorts in that the voter casts their vote electronically, reviews their choices and prints a paper ballot of the voter's choices. The paper allows the voter to double check their choices before casting their vote.

Mr. Brian Massie of 8196 Rainbow Drive in Painesville, on behalf of Lobbyists for Citizens, expressed his groups' displeasure with the Common Pleas Judges and the accusations currently pending in the Ohio Supreme Court brought by Clerk of Courts, Ms. Faith Andrews against the Judges. He addressed Mrs. Pokelsek directly with his group's opinions and how they have deemed Lake County elections safe.

Commissioner Plecnik thanked the Prosecutors for being good counsel to the Board of Commissioners. Mr. Dale Fellows, Chairman of the Lake County Board of Elections, also explained to Mrs. Pokelsek in detail how the voting machines work in the Board of Elections and assured her that they are extremely safe. He explained that Secretary of State, Mr. Frank LaRose, is huge on cybersecurity and has received national recognition for his work.
