CALL TO ORDER: Commissioner Hamercheck called the Meeting to order at 10:06 a.m. Thursday, June 2, 2022.

ROLL CALL: Upon roll being called, Commissioners: Plecnik and Hamercheck were present.

<u>OPEN TO THE PUBLIC</u>: Commissioner Hamercheck asked if anyone in the audience wished to address the Board. No one present wished to address the Board at this time.

RESOLUTIONS:

RESOLUTION PROCLAIMING WORLD ELDER ABUSE AWARENESS DAY IN LAKE COUNTY, OHIO (20220602\F01)(C-126)

On a motion by Commissioner Plecnik, seconded by Commissioner Hamercheck. Commissioner Plecnik stressed the importance of drawing attention to elder abuse as senior citizens are among our most vulnerable citizens. Most elderly do not realize that they are being abused or neglected. He stated that it is so very important to bring this to the public's attention. Job and Family Services Director, Suzanne Casar, stated that June 15, 2022 is World Elder Abuse Awareness Day here in Lake County and across our country. It is the time of year when cities and states can take a moment to shed light on this significant issue. Lake County Job and Family Services is mandated to investigate each and every call and report they receive. She reported that during the year 2021, her department responded to over 430 calls concerning abuse, neglect or exploitation of a senior. Ms. Casar stated that Lake County is fortunate to have a dedicated unit of social workers who investigate elder abuse and neglect. Anyone who suspects an elderly individual in our community is being abused, neglected or exploited should contact their agency at their hotline to report any abuse or neglect of seniors. This hotline is manned 24/7 and the number to call is 440-350-4000, Option #1. She introduced Assistant Administrator from Job and Family Services, Ms. Mary Udics. Ms. Udics thanked the Board of Commissioners for their continued support of Elder Abuse Awareness. She stressed that "if you see something, say something". The Board and Ms. Udics discussed red flags for people to watch out for as well as the different ways in which the elderly can be exploited. Ms. Udics announced that the Department of Job and Family Services will host a World Elder Abuse Awareness walk on June 15 at 11:45 AM beginning at Job and Family Services and concluding at Veterans Park in the Painesville Square. All are welcome to attend and participants are encouraged to wear purple, the color designated for elder abuse awareness. Commissioner Plecnik reminded everyone that "if you see something, say something" and how they should call 440-350-4000, Option #1 with concerns. Council on Aging Director, Mr. Joe Tomsick, stated that this resolution means so much to so many in the community. He thanked Director Suzanne Casar and Mary Udics for the incredible work of the adult protective services division as their team plays such a vital role in protecting the most vulnerable of our community. 1. RESOLUTION CONGRATULATING CAPTAIN CYNTHIA BROOKS RECIPIENT OF THE RAY COLEMAN ADMINISTRATOR OF THE YEAR(20220602\F02)(C-126)

On a motion by Commissioner Plecnik, seconded by Commissioner Hamercheck. Sheriff Leonbruno stated that Captain Brooks has contributed more than 38 years of service to the Lake County Sheriff's Department where she currently serves as the Jail Administrator. He spoke of the major impact she has had serving Lake County. Captain Brooks has developed several programs one of which is the WITTS (Women in Transition Through Support) program to assist women in reuniting with a positive, healthy environment minimizing the circumstances that led to their incarceration. The focus of the program is to increase employment skills, develop positive relationship values and support, elevate their educational level, build self-esteem, control choices through anger management, build strength through drug/alcohol treatment, and develop a strong family structure. She oversees approximately 385 inmates per day and 85 Corrections Officers, medical staff, kitchen staff, and mental health treatment staff, drug and alcohol treatment staff. This year she was unanimously chosen across the country as the recipient of the Ray Coleman Correctional Administrator of the Year by the American Jail Association.

Captain Brooks thanked the Board for the resolution and discussed that it has been an extreme honor to receive this award and she has worked hard for 38 years to create programs to assist those incarcerated. Commissioner Hamercheck stated that her energy and enthusiasm shines through and that she has a true servant's heart. He congratulated her on this well-deserved recognition. Commissioner Plecnik congratulated Captain Brooks and stated that it is a true honor to have her serving Lake County.
