Eastlake Women's Club Held Human Trafficking Awareness Forum

PAINESVILLE, Ohio, January 23, 2023— Eastlake Women's Club hosted a Human Trafficking Awareness Forum on January 14, 2023 at Regovich Catering. The purpose of the forum was to inform attendees of the signs of Human Trafficking and what to do if they were to encounter a possible instance.

The Lake County Collaborative to End Human Trafficking spoke at the event teaching the signs and responses individuals can take should they encounter human trafficking.

At their January 12th meeting, the Lake County Board of Commissioners also declared the month of January, 2023 as Human Trafficking Prevention Month in Lake County, Ohio.



"This is a very real problem throughout not only Lake County and Ohio but all around the country," said Commissioner John R. Hamercheck. "It is important that we, as a community, do everything in our power to prevent it."

After attending the event, Commissioner John Plecnik added, "We are proud to support the Lake County Collaborative to End Human Trafficking in recognizing January as Human Trafficking Prevention Month. The time has come to put an end to this evil crime in our community, and to quote Justice Brandeis, sunshine is the best disinfectant."

Ohio ranks fifth in the nation for human trafficking cases. New legislation in Ohio has doubled the number of task forces, however, the best way to combat human trafficking is making the public aware of the issue and the warning signs.

"Informing and educating our community is a key factor in preventing human trafficking from happening," said Commissioner Richard J. Regovich. "Thank you to Eastlake Women's Club and The Lake County Collaborative to End Human Trafficking for bringing attention to this issue.
