BE IT RESOLVED, by the Board of County Commissioners, in and for Lake County, Ohio, that to provide for the current expenses and other expenditures of said County, during the fiscal year ending December 31, 2023, and the following sums being the same are hereby set aside and appropriated for the several purposes for which expenditures are to be made during said fiscal year of 2023 and that this be a PERMANENT APPROPRIATION for the year 2023, pursuant to O.R.C. 5705.3 and the sums and categories appropriated to be as follows:

Attached are a few documents summarizing the proposed 2023 budgets for all Outside General Fund accounts. The first is a summary which includes the estimated unencumbered cash balance, estimated revenues and appropriations (2023 OGF Budget Lead Sheet), the proposed resolution which includes a line item breakdown of all appropriations (2023 OGF Temp Budget) and a recapitulation of appropriations' various cost centers (2023 OGF Temp Budget Recap).

We have provided three binders of funds outside of the General Fund. Included in these binders will be all of the department requests, calculations for the estimates and all other pertinent information used to create the proposed budgets, detailed line item breakdowns for proposed revenues and appropriations along with the attachments noted above. These binders will be placed on the fifth floor by your in boxes.

To provide you with a quick summary, the estimated revenues total \$250,628,101.25; and the appropriations total \$314,619,146.50 for the proposed 2023 Outside General Fund Budgets. In comparison the 2022 temporary budgets estimated revenues totaled \$270,835,653.94 and appropriations totaled \$296,791,996.46.

The Outside General Fund resolution will be placed on the agenda for the meeting of March 30, 2023 for consideration. If you have any questions and/or concerns, please let me know so they can get addressed. This is a draft and am still working with the Utility Department for some possible changes. This will be one of the topics at the work session scheduled at 9:00am on March 23, 2023 and subject to change. General Fund will be provided shortly.
