CALL TO ORDER: Commissioner Hamercheck called the Meeting to order at 10:00 a.m. Thursday, August 3, 2023.

ROLL CALL: Upon roll being called Commissioners Regovich, Plecnik, and Hamercheck were all present.

OPEN TO THE PUBLIC: Commissioner Hamercheck asked if anyone in the audience wished to address the Board. Captain Cynthia Brooks was recognized for 39 years of dedicated service in the Sheriff's Office. During her career Captain Brooks served as a Sergeant, a Lieutenant, and a Captain. She also served as the Jail Administrator where she was awarded "Correctional Administrator of the Year" in 2022; a national recognition that consisted of hundreds of nominees. The Board presented her with a certificate of appreciation and unanimously expressed how greatly she will be missed. Tony Brooks, Sheriff Leonbruno, Bishop Mirbel, Brian Massie, and Prosecutor Coulson all offered their best wishes and their recollections of Captain Brooks.

Michael L. DeLeone was recognized for his recent appointment by Governor DeWine as Judge to the Court of Common Pleas-Juvenile Division. He had been working as an Assistant Prosecuting Attorney for over 20 years and will begin his term as Juvenile Judge on August 14th. The Board presented him with a certificate of recognition and unanimously expressed how deserving Mr. DeLeone is of this appointment. Prosecutor Coulson, Adam Litke, Randy Rothlisberger, Jason Boyd, Jennifer Bell, and David Hackman all offered their congratulations and sincere appreciation for his assistance through the years.

<u>NEW BUSINESS</u>: The Commissioners praised the Fair Board on the success of the 2023 Fair and shared some of their experiences from last week. They thanked the Board for all the hard work that goes into making it such a well-attended event.

Brian Massie of 8196 Rainbow Drive in Concord cited a letter from Prosecutor Coulson in response to Commissioner Hamercheck's question, should the Budget Commission continue to apply the alternative method of apportionment of local government funds after the BOC adopted a resolution in January of 2012 requesting that the alternative formula approved in 1982 for the distribution of local government funds be abolished. David Hackman (Prosecutors Office) informed Mr. Massie that there is a Budget Committee meeting this coming Monday (8/7) and he anticipates any questions of this nature will be addressed at that time.

Tammy Gabor of 6023 Ford Rd in Madison said she appreciates the Board's efforts at finding a financial solution to Ford/Williams/Paine roads. She asked a few questions of Traci Salkiewicz (Engineer's Office) regarding project prioritization, funding, timing, etc.

Chris Weiss of Leroy echoed some of Mr. Massie's questions concerning fund distribution. Mr. Hackman responded that, due to the very complex nature of the formula, it is best to wait until the Budget Commission holds their Monday meeting.

Tim Brown, Madison Twp. Administrator, asked if Items 14 and 15 had anything to do with funding being appropriated for line items regarding road and bridge work that was discussed a few weeks ago to help fund those projects. The Board responded they do not.

Christopher Galloway (Auditor) cautioned against any speculation as to who will get what in regards to the local government funding formula. He encouraged all local municipalities to send a representative to attend the Budget Commission meeting on Monday August 7th.

John Marra, Mayor of Timberlake, stated that he visited the Madison road closures and asked if it would be possible to find a temporary solution so roads can be used in the interim. Ms. Salkiewicz responded that the idea proposed by Mr. Marra is not feasible for this area. A solution is needed that will last at least 15 years and be within the budget they have available because spending additional monies for a temporary solution is not a viable option. Commissioner Hamercheck agreed and suggested Mr. Marra schedule a meeting with the Engineers Office if he has other suggestions.

<u>ADJOURN:</u> On a motion by Commissioner Plecnik seconded by Commissioner Regovich, the Board adjourned the meeting at 11:58 a.m. with the vote as follows: "AYES": Commissioners Regovich, Plecnik and Hamercheck "NAYS": None.
