He spoke of the Ohio EPA Universal Waste Collection Grant they received and will be used for special collections of items such as tires, batteries, aerosols and televisions.

<u>JOB AND FAMILY SERVICES</u> – Ms. Casar reminded everyone that the 4<sup>th</sup> Annual World Elder Abuse Awareness Day walk will take place this Thursday, June 12<sup>th</sup> at 11:45 AM.
