CALL TO ORDER: Commissioner Regovich called the Meeting to order at 10:00 a.m. Thursday, October 23, 2025.

ROLL CALL: Upon roll being called, Commissioners: Beverage, Plecnik and Regovich were present.

#### APPROVAL OF MINUTES:

OPEN TO THE PUBLIC: Commissioner Regovich asked if anyone in the audience wished to address the Board. Commissioner Regovich introduced Senior Services Coordinator, Ms. Alyea Barajas, to speak about Mr. Tom Dreher who was present to receive a special certificate for his years of service to the Senior Advisory Panel. She thanked Mr. Dreher for his many years of service on the Senior Citizen's Advisory Panel sharing that he has served on this panel since its inception in 2012. She stated that as the last remaining original member, Mr. Dreher has provided invaluable perspective over the years and consistently brought thoughtful insight and honesty to the group, carefully reviewing funding requests and often creating graphs to emphasize his points, which were very much appreciated. Ms. Barajas explained how he also shared his life experiences through several self-published books which he graciously shared with his fellow panel members over the years. His presence and perspective will be deeply missed. Mr. Dreher thanked the Board and Mrs. Barajas for the honor and pointed out how Mrs. Barajas and Mrs. Kane are true gifts to Lake County and its seniors. Commissioner Regovich shared what a fearless leader Mr. Dreher was when he served as Willowick City Mayor sharing several stories of letters (written by Mr. Dreher) he found in the archives when he served as Mayor. Commissioner Plecnik stated that Mr. Dreher has always encouraged him and included him on his book publishing list.

## 1.PROCLAIMING OCTOBER 2025 NATIONAL DOMESTIC VIOLENCE AWARENESS MONTH IN LAKE COUNTY, OHIO(20251023\F01)(C-126)

On a motion by Commissioner Beverage, seconded by Commissioner Plecnik. The Board expressed its gratitude and thanks to Forbes House and its Executive Director Kathy Strancar for their continued commitment to our community in Lake County and Northeast Ohio. Forbes House is the only domestic violence shelter in Lake County so it bears an incredible responsibility to protect the many vulnerable communities that need their services. Ms. Strancar was present and stated how appreciative they are for the Commissioners' continued support for Forbes House and the work of her staff and advocates. She shared how unfortunately and tragically there were to fatalities in Lake County as a result of domestic violence. She revealed that many suffer in silence; one in three women and one in four men will face intimate partner abuse. If we don't recognize the signs early, the cycle may lead to tragedy. Domestic violence is a community issue, not a private one, and silence keeps survivors trapped. It's preventable, not inevitable. Ms. Strancar stressed that Forbes House is the foundation for change and last year alone, they served 541 individuals, and sheltered 174 survivors, 70 of them children. ### **DEPARTMENTAL REPORTS:**

<u>UTILITIES</u> — Commissioner Plecnik asked Sanitary Engineer, Mr. Rothlisberger, to comment on the rain event Lake County experienced yesterday. Mr. Rothlisberger stated that depending on where you were in Lake County over the past 12 hours, there was an amazing amount of rain. In the north and the south of the County, about half an inch of rain was recorded however, throughout the center of the County including Fairport Harbor, Painesville Township, and Madison, up to eight and a half inches of rain was recorded at the landfill in about 10 hours. The last time he personally experienced this was back in 2006 when they recorded 10 or 11 inches of rain. He explained that quite a few streets are flooded and closed due to water in Fairport Harbor and the landfill has some roads flooded which is causing some delays today. Mr. Rothlisberger assured everyone that their systems are functioning as they should, but the amount of rain received in Lake County has overwhelmed the system.

JOB AND FAMILY SERVICES — Director of Job and Family Services, Ms. Suzanne Casar, provided an update on the status of SNAP benefits stating that the latest communication she received from the Ohio Department of Job and Family Services is that the federal shutdown may cause a delay in new/renewed issuance of SNAP benefits starting on Saturday, November 1st. At this time, it is unknown how long the delay will last, and updated information will be on their website as soon as it becomes available. They will continue to process new applications and client recertifications for food assistance benefits so that when federal funding resumes, those benefits can be issued. Ms. Casar wanted to stress that Lake County Job and Family Services does not have any control over when benefits will be available because these benefits are provided by the federal government. She encouraged the public and their community partners to become more aware that clients may be reaching out to food pantries and an email will be sent out today explaining that SNAP assistance for the month of November may be delayed and that local agencies can expect an increase in individuals visiting their facilities. Ms. Casar stated that her public assistance administrator will provide an update to the Board on the upcoming changes to public assistance and childcare eligibility starting November 1 due to Ohio House Bill 96 and the One Big Beautiful Bill Act.

<u>COUNTY ADMINISTRATOR</u> – Mr. Boyd stated that a steel topping ceremony for the new Public Safety Center Project will take place November 13<sup>th</sup> at 9 a.m. and signifies a huge milestone in the project. He addressed the State of the County presentation which was scheduled for next week and requested an extension to the first week of November. He explained that he would need a motion from the Board for that extension to be approved. Commissioner Beverage made a motion to delay the State of the County presentation for one week, seconded by Commissioner Plecnik, motion was approved with the vote follows: "AYES": Commissioners: Beverage, Plecnik and Regovich "NAYS": None.

<u>CLERK</u> – Commissioners Clerk, Ms. Jennifer Bell, stated that the next Regular Meeting is scheduled for Thursday, October 30, 2025, at 10:00 am followed by a Workshop at 10:30.

LEGAL - none.

OLD BUSINESS: none.

NEW BUSINESS: Commissioner Regovich stated that there will be a discussion on a potential Piggyback Homestead Exemption and Piggyback Owner Occupancy Credit. Commissioner Plecnik explained that the State has voted to give every county the authority to double the current owner-occupied credit and homestead exemption for property taxes. Unlike the base homestead exemption and owner-occupied credit which are reimbursed by the state, this exemption means every local taxing entity receives proportionately less depending on their share of property taxes. This is a modest tax cut and reduces revenue to all local governments including Lake County. He does not believe that these two cuts are sufficient to address the significant problem of the inflationary increases, but every little bit He stated he supports expanding both the owner-occupied credit and the homestead exemption. Commissioner Plecnik stated the Board is exercising the authority the state has given to make the biggest difference possible at this time. Commissioner Beverage stated that this is not a total solution and more work needs to be done to address this. He explained that the state budget gave counties these two provisions and unfortunately for this to go into effect for this tax year for collections next year a decision must be made by October 31st. He stated that the Board does not have all the necessary data available, so they will address this issue with the tools that are currently available and continue to advocate for the taxpayers and work with the state to address this issue going forward. This may not result in a huge impact on an individual's tax bill, but these are the tools currently available and for the taxing entities across the county whose budgets this affects. He stressed that this Board is trying to be as transparent and open as possible, and he appreciates everyone that he has spoken to within the community and other entities for their understanding and support of the decisions that the Board must make. Commissioner Regovich explained that the Boards job is to take what the state and the federal government provides and see how it works best for Lake County. Their sole power at this time is to provide some relief to seniors in our county and he

feels as a good steward of the county this change should be made. He explained how taxing entities have followed the rules that the state has in place for over 50 years but how they (the state) haven't changed in 50 years. He reiterated that this will not be a huge savings, but it will help. He shared how fortunate Lake County is to have its finance team, to be financially solvent, and to have budgets consistently come in strong every year, and the County must also protect that. He wanted to reassure the public that this decision has not been taken lightly, there have been many discussions, and he will continue to have discussions with the taxing agencies. 

Commissioner Plecnik wanted to thank Commissioner Beverage for taking the time to organize a forum with all the school superintendents and local governments to discuss this issue before any vote was taken. He stated that this conversation has to continue and he appreciates the effort that Commissioner Beverage has put in to bring the entire community together to discuss this. He thanked County Auditor Galloway for advocating for the County and for going to Columbus to testify on these bills and make our county's position and concerns known. Commissioner Plecnik provided some history on when the state sales tax was first adopted back in 1934 and also the state income tax which was decades later. He explained that taxes have helped fund local government and schools but as time went on more of those dollars stayed in Columbus to be spent on state priorities rather than going back to local government and schools. He stated that there was a huge acceleration under Governor John Kasich when he began slashing the local government fund and keeping the money in Columbus in order to declare a balanced budget. He further stated how we have experienced very high inflation since COVID and that property tax values go up with inflation. The County has seen record foreclosure rates which will only increase because the next revaluation is likely to result in another 25% increase in property tax values. He spoke on Article 6, Section 2 of the Ohio Constitution which makes the state responsible for funding public schools but more than 60% of our property taxes are paying for them. Commissioner Plecnik stated this is not a local issue but requires a change in the Ohio Revised Code. He encouraged residents to actively reach out to their state representatives and senators who make the laws.

<u>EXECUTIVE SESSION</u>: On a motion by Commissioner Beverage, seconded by Commissioner Plecnik, the Board convened an Executive Session at 10:52 a.m. to discuss Legal- Pending Litigation with the vote as follows: "AYES": Commissioners: Plecnik, Beverage and Regovich "NAYS": None.

The Lake County Board of Commissioners adjourned to Executive Session at 11:44 a.m.
