WHEREAS, the Lake County Engineer has reviewed bids received and has recommended that award of contract be made in accordance with said proposal to American Roadway Logistics, Inc. of 2661 Barber Road, Norton, Ohio 44203-1056, it being the lowest and best bid received.

NOW, THEREFORE, BE IT RESOLVED, that the Board of County Commissioners, in and for Lake County Ohio, hereby award a bid contract to American Roadway Logistics, Inc. of 2661 Barber Road, Norton, Ohio 44203-1056 for the Pavement Markings – SR2 - 2025 for the Lake County Engineer's Department in the amount of \$129,031.00.
