AMENDED ANNUAL ACTION PLAN/FISCAL YEAR 2019 PROPOSED PROJECT AND ACTIVITIES
FOR PUBLIC SERVICES TO SUPPORT INFECTIOUS DISEASE RESPONSE**

The Lake County Board of Commissioners announces the proposed project and activities to be funded with the Fiscal Year 2019 special allocation funds and prior year funds of Community Development Block Grant Program from the U.S. Department of Housing and Urban Development (HUD). The special allocation funds are to be used to prevent, prepare for, and respond to the coronavirus (COVID-19). This allocation was authorized by the Coronavirus Aid, Relief, and Economic Security Act (CARES Act), Public Law 116-136.

A. Community Development Block Grant (CDBG) Program proposed use of funds by project & activity for the Round 2 period:

- 1. Assistance to Businesses, including Special Economic Development Assistance Amount: \$280,000.00**
Lake County Small Business Assistance Programs: Microenterprise Emergency Relief Grant Program and Emergency Working Capital Loan Program (\$280,000)

- 2. Public Services to Support Infectious Disease Response Amount: \$82,700.00**
Ecumenical Shelter Network of Lake County, Inc., Warming Up and Saving Lives at Project Hope (\$27,500); Fair Housing Resource Center, Foreclosure Prevention Counseling (\$30,000); Lake County Council On Aging, Meals on Wheels Senior Protection Program Equipment (\$8,500); Lifeline, 2-1-1 Lake County Pandemic Response (\$7,500); Lifeline, Code Blue (\$7,600); Willow Praise Assembly of God, Emergency Food Distribution Equipment (\$1,600)

- 3. Buildings and Improvements, Including Public Facilities Amount: \$61,400.00**
Extended Housing Inc., Automated Doors to Reduce the Spread of COVID-19 (\$23,900); Lake County YMCA, Safety for Health Seekers, HVAC (\$37,500)

- 4. Program Administration Amount: \$144,055.00**
Planning and program administrative costs (\$144,055)
